

## Terms & Conditions

1. This Campaign is applicable to new and existing customers (primary account holders only) of Maybank Premier Wealth and who meet certain eligibility requirements and qualifying criteria set by Maybank (Cambodia) Plc. (“Maybank”). This Campaign is valid from 1 August to 31 December 2016.
  2. New customers must place with Maybank a minimum of USD25,000 fresh funds in the Maybank Prestige Current Account on the date the account is opened with Maybank.
